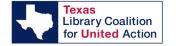

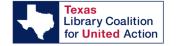

TLCUA: Selected Goals

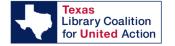
Negotiations are conversations, give and take

- A new contract with Elsevier by 12/31/20
- A balanced approach to faculty ownership of scholarly work
- Accelerate new discoveries by making research more widely accessible and visible
- A more open and sustainable scholarly publishing ecosystem
 - Publisher pricing models are still based on decades-old print subscriptions!
- A mutually beneficial partnership of strength and mutual contribution
- Reduce costs, immediate and ongoing (annual price increases)



TLCUA: The Why

- A commitment to change the negotiations dynamic in that:
 - We are stronger together
 - Our goal is an agreement, but we are prepared, if necessary, to walk away from negotiations with a plan for alternative access
- A structure that is more reflective of the essential contributions of faculty authorship, editing, and review
 - These contributions **are** scholarly communications!
- Some commercial publishers, particularly Elsevier, make exceptional profit margins
 - Built-in annual price increases well above national inflation rates



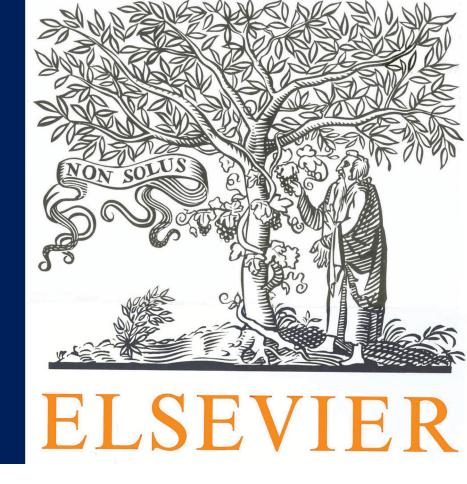
TLCUA: The How

- "Inspired" by Univ. of California libraries in March, 2019 who walked away and lost access to current Elsevier content
 - More recently <u>MIT libraries in June, 2020</u> withdrew and lost access to current content
- Other libraries (UNC, LSU, etc.) have withdrawn from "the big deal"
- Improvements in alternative access to content
- Realizing that vendor-supplied usage counts ≠ value
- New tools of analysis, such as <u>Unsub</u> from <u>OurResearch</u>
 - Reveals titles that can be cancelled with minimal negative impact and replaced with OA, doc delivery, backfiles, etc.
- If a new agreement is delayed, there may be a loss of convenience but **never loss of access**

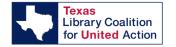

Why Elsevier? Elsevier's size and market share

- The world's largest publisher of scholarly content; this single publisher consumes a significant percentage of library serials budgets
 - o 2019 revenues: \$3.4 billion
 - o 2019 revenues are nearly 28% higher than 2015
 - Market share: 18% of peer-reviewed journal articles worldwide
- It makes a whole bunch of money!
 - Elsevier 2019 profit margin: 37.2%
 - Some perspective: the profit margin for Apple is 24.5%, Walmart 4.3%, Amazon 5.2% and Alphabet (Google) 19%
- Aggressive market expansion: Aries, Mendeley, SSRN, Plum Analytics, and Bepress
 - We are "...a global information analytics business..." (Elsevier: <u>About statement</u>).
 - That is, not a publisher



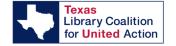
2 Why Us? Who we are and what we stand for

- We know that the scholarly communications system is vital and must be sustained -- but we also believe it needs to change
- We believe the system should better serve the mission and values of our institutions and give less priority to the shareholders of for-profit companies.
- Together, we can reduce costs but it's not just about money.
- Together, we can improve access to research and empower faculty with greater control and ownership of their scholarly work.



3 Why Us? As a Coalition, we have leverage

- In 2019, the Universities in the Coalition accounted for:
 - At least 7.2% of all research output in the U.S.
 - About 6% of all U.S. research published by Elsevier
- TLCUA affiliates occupy over 1,500 of Elsevier advisory and editorial board positions
 - ~1.3% of all editors and ~3.9% of all US editors
- The spend by Coalition Libraries for Elsevier journals is over \$25 million annually!
 - Compare to UC libraries @ \$11M -- Texas Coalition is more than double!
- Both high teaching and high research institutions including world-renowned medical research institutions
- We are formally committed through a commonly-signed MOU by all members



4 Why Now? A global movement is gathering

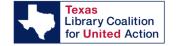
We are not alone

- OA2020 global initiative: 100+ signatories in 25 countries
- University of California System has withdrawn from negotiations with Elsevier for more than one year; MIT more recently

Europe is challenging Elsevier and subscription-based publishing

 Germany's <u>Projekt DEAL</u>, <u>Bibsam Sweden</u>, Finland's "<u>No deal, no review</u>", <u>Plan S</u>, EU's <u>Horizon 2020</u>

For the industry to change, North American institutions (estimated at 42% of Elsevier's revenue) must get involved. Through the Coalition, an opportunity for Texas to lead!



Negotiation Outcomes: Two Key Scenarios

Agreement reached by 12/31/2020 Delay: no agreement by 12/31/2020

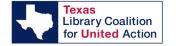

Agreement not reached by 12/31/2020 Access to current content removed by Elsevier

Our goal is a successful agreement, not withdrawal, but if...

- No impact on publication choice for authors, editors, reviewers
- Continued access to library-purchased "backfiles" of subscribed content
 -- this can be substantial
- We will seek to continue negotiations in 2021 and eventual agreement
- Libraries may use saved resources to enhance doc delivery
- Will promote use of tools, such as OA button, for immediate access
 - Estimates as high as 50% of current published content is OA
- Libraries with contract expiration of 12/31/21 will see no change at all
- Potential loss of convenience but not loss of access



2 Negotiations Successful

Will depend on final agreement but we seek:

- Immediate cost reductions (for institutions with contracts expiring 12/31/20)
- Improvements in faculty ownership of scholarly work
- Ongoing cost controls
- Potential for digital approach to collaborative collection development
- The Coalition will have an influential role in transforming scholarly communications nationally and globally
